These shares are still standing in the name of above stated promoters in physical form in member register. *Further as per our member register, Munak International Pvt. Ltd.(MIPL) is holding 2250 shares (after sub-division 4500 shares) in D-mat form. However out of this, 50 shares (after sub-division 100 shares) had already been sold by MIPL long back. Therefore its actual holding is 2200 shares (after sub-division 4400 shares).

Textual Information()	1) Individuals/entities specified in Table II form part of Promoter & Promoter Group 2) Number of promoters and promoter group are 28. Steel Strips Industries Ltd, Indian Acrylics Limited, Steel Strips Infrastructure Limited, Indlon Chemicals Limited, SAB Developers Pvt. Ltd, Steel Strips Mercantile Pvt Ltd, Indian Acrylics Investments Ltd, R. K. Garg & Sons (HUF) and Hans Raj Trust does not hold any equity shares of the Company but they also form part of the Promoter Group of the Company. 3) Steel Strips Ltd. (SSL) has been amalgamated into SAB Industries Ltd. Therefore SSL does not exist as on date. However we are showing the name of SSL because as per our member register SSL is holding 300 shares (after sub division 600 shares) whereas SSL has sold these shares long back and the purchaser did not lodge the same in his own name. 4) The BOD and members of the Company at their respective meetings held on 03.09.2021 and 30.09.2021, have inter alia approved sub-division of its existing 1 equity share of FV of Rs.10/- each into 2 equity shares of FV of Rs. 5/- each. BOD had fixed 22.11.2021 as the record date said sub-division. Thus, in this shareholding pattern the effect of sub-division has been taken. Besides this, there is no change in the share capital of the Company for the reporting period.
